2. **Ramdhuni Municipality, Office of the Municipal Executive** invites sealed bids or electronic bids from eligible bidders for the Construction of Primary Hospital (15-Bed) At Ramdhuni Ward 6 under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible Bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 11,00,00,000.00
- Minimum Work experience of similar size and nature: *Two RCC Building of Minimum Amount NRs 12,00,00,000.00 each.*
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 PM On 2078.02.30 at the Office of Ramdhuni Municipality, Jhumka, Sunsari. Bids must be valid for a period of 120 days after bid opening and must be accompanied by bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs 43,00,000.00, which shall be valid for 30 days beyond the validity period of the bid.
