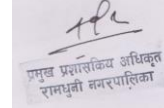

5. Only electronic bidding through e-GP portal of PPMO is permitted. Bidders who wish to participate in the bidding may download the bidding documents from PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders should deposit the cost (as specified above) of bidding document in the account details as specified above
6. Only Electronic bids should be submitted through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 noon on **2079/01/25**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend on **2079/01/25, 1:00 noon** at the office of **Ramdhuni Municipality, Office of the Municipal Executive**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **1,00,000.00 (In words Nepalese Rupees one lakh only)** which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
